Scholarships: We provide scholarships to graduating seniors of Irving Independent School District (IISD). The students submit applications for our scholarships which are reviewed by a group of volunteers and donors.

After a thorough review process, we determine the candidate that best meets the qualifications and award to that student. Once the student arrives at their university, the student must send proof of enrollment, an invoice showing a balance due, and a schedule showing that they have registered for at least 12 hours of classes. Once we verify this information, we send the payment directly to the university to be used for tuition only.

Educator Grants: Teachers and other IISD staff may apply for our grants through our online grant system. They must explain what the grant is to be used for. Once they submit their request with a detailed budget, their grant goes through a thorough review process. The principal on their campus must first review the grant, followed by the chair of our programs committee. Once approved, we process a check and send it directly to the school that applied for the grant money.

Teacher of the Year Awards: One teacher at each campus is recognized as well as a district-wide honoree for elementary and secondary Teacher of the Year award.

Other Non-cash assistance: More than 75% of Irving ISD students struggle with intermittent or ongoing food insecurity. The organization distributes food bags to those students in need. The organization also assists students with obtaining necessary school supplies as well as organizing an annual holiday gift drive and distribution program.
